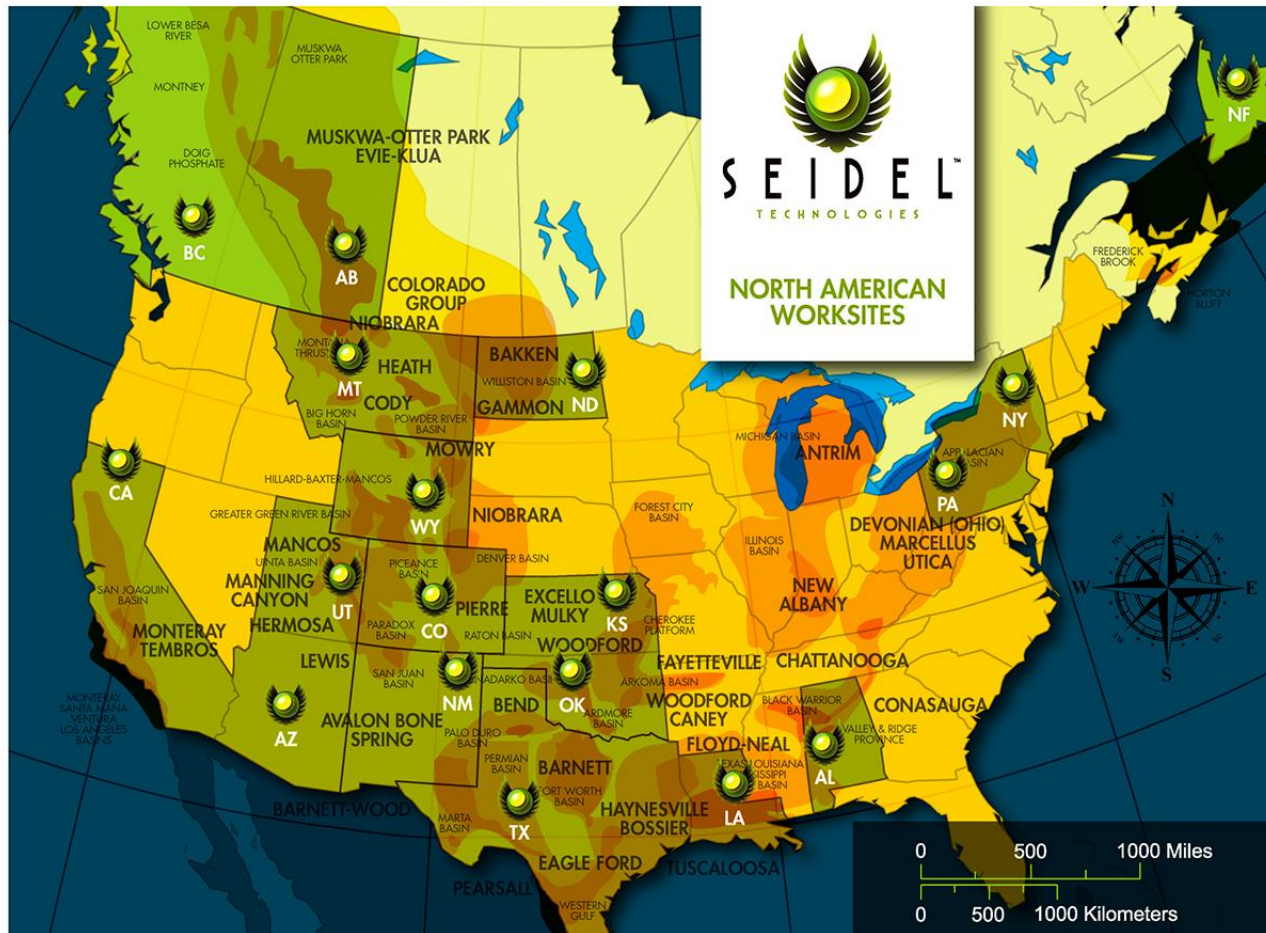

 - Multi leg horizontal coal wells in San Juan Basin – 4mmcf /3bcf
 - Realized asset value enabling KKR purchase

November 23, 2011

KKR Will Acquire Samson Investment for \$7.2 Billion



- **2010-12 Helis Oil & Gas – Drilling Management**
 - Only 9 wells drilled in 18 months prior
 - Drilled 30 wells in 18 months after assuming drilling management
 - Enabled well inventory for frac stimulation
 - Realized 1.0 – 1.5 mmbo wells
 - Realized asset value enabling QEP purchase

 - Highly visible well under public scrutiny
 - Rank wildcat drilled successfully totally transparent with local community
 - Demonstrated ability to efficiently drill in highly contingency environment

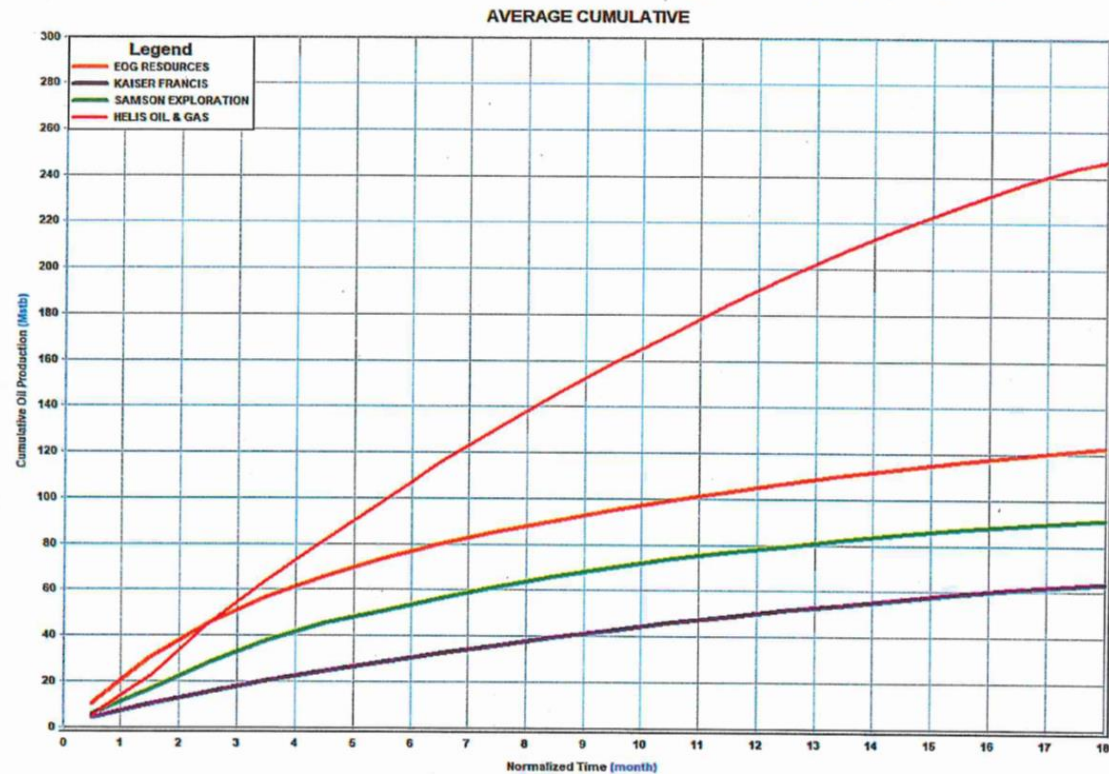

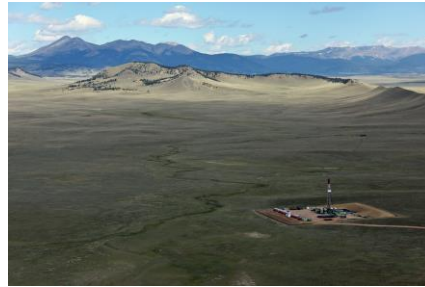

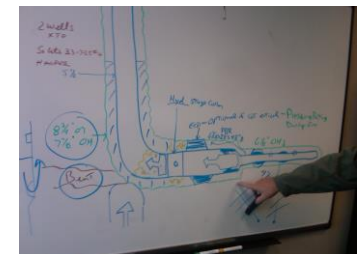
